That one word sums up our 2015 fiscal year. Through the hard work of many, our health system expanded by leaps and bounds.

We opened the largest ER in Acadiana (beginning our journey to become a Level II trauma center), announced a partnership for radiation therapy and signed a collaboration agreement with Opelousas General Health System – all in the first quarter.

Then came a new telemedicine clinic at Lafayette
Consolidated Government, becoming a founding member
of the Ochsner Health Network, officially assuming
management of Abrom Kaplan Memorial Hospital, caring
for victims of the Grand Theatre shooting and adding Iberia
Medical Center as a clinical affiliate.

At the end of the fiscal year, our biggest announcement was revealed to the community. On August 19, 2015, we publicly declared our intent to acquire Regional Medical Center from HCA, eventually transitioning the hospital as Lafayette General Southwest on November 6, 2015.

We expanded our system while continuing our awardwinning service. Lafayette General Medical Center earned the Louisiana Quality Foundation's (LQF) highest award, the Louisiana Performance Excellence Award. The LQF awards program recognizes performance excellence in both profit and non-profit Louisiana organizations in the areas of manufacturing, service, health care, education and the public sector. Our IS Department was named one of the best in information technology by two different organizations and St. Martin Hospital was named a Best Place to Work in Healthcare by *Modern Healthcare* magazine for the second year in a row!

Our health system was active in the community, providing education, seminars and free screening opportunities to make the people in Acadiana healthier.

And with all of that, we added more physicians to our medical staff, provided more graduate medical education, saw more patients, took care of more emergency cases, performed more surgeries, delivered more babies, provided more charity care and raised the bar...**wow.**

From the bottom of my heart, I can't express how genuinely grateful I am to each and every one of our employees. 2015 was fast paced and undoubtably exhausting at times. It would not have been so successful without their dedication and a true desire *To Restore, Maintain and Improve Health*.

LAFAYETTE GENERAL HEALTH

Lafayette General Health (LGH) is a non-profit, communityowned regional healthcare system committed to always delivering excellence. LGH serves the south-central region of Louisiana by aligning with facilities across the 10-parish area of Acadiana. As a member of the Ochsner Health Network, LGH is part of an alliance of healthfocused entities across the greater Gulf South region.

THE SYSTEM LGH's flagship hospital, Lafayette General Medical Center (LGMC), in operation since 1911, is a 501(c)(3) not-for-profit corporation that does not pay out any revenue to shareholders as for-profits do. LGH also owns or manages Lafayette General Southwest (LGSW) (as of 11/6/15), Lafayette General Surgical Hospital, University Hospital & Clinics (UHC), St. Martin Hospital, Acadia General Hospital and Abrom Kaplan Memorial Hospital. As of the close of the 2015 fiscal year, LGH had clinical affiliations with Abbeville General Hospital, Bunkie General Hospital, Franklin Foundation Hospital, Iberia Medical Center, Savoy Medical Center and a collaboration agreement with Opelousas General Health System. LGH owns Lafayette General

Medical Doctors, a non-profit corporation that operates and manages several physician clinics in many different specialties that includes 51 staff physicians and 7 nurse practitioners.

EDUCATION Both LGMC and UHC are major teaching hospitals, providing graduate medical education (GME) across many disciplines. The growth of GME across the two campuses has led to a vibrant culture of education throughout LGH. At the close of the fiscal year, LGMC and LGSW were preparing to launch a Nurse Residency Program.

GROWTH Since 2011, LGH has witnessed growth each year in the number of patients discharged from our hospitals, the number of ER visits and total net revenue. All of this while the total number of hospitalized patients in Acadiana is shrinking. In 2015, LGH offered community benefits in excess of \$250 million - totaling over half a billion dollars in the past two years combined. LGH employs approximately 4,000 people and is the largest private employer in Acadiana.



LAFAYETTE GENERAL MEDICAL CENTER

Lafayette General Medical Center (LGMC) continued to raise expectations and produce excellence in fiscal year 2015. That was evidenced by more medical firsts, a stream of prestigious awards and new heights for multiple service lines.

BRINGING IT HOME In April, LGMC celebrated 50 years in the Oil Center by burying a time capsule. However, the hospital preferred to look ahead. It was the first full year with the new ER & OR platform. A new cafeteria opened. Most importantly, LGMC experienced incredible medical breakthroughs.

LGMC was among the first in the nation using a new system to treat coronary artery disease, and to use a drug-coated balloon catheter. LGMC introduced Acadiana's first *da Vinci*® Xi Surgical System. LGMC was the second hospital in the world to pioneer the BrightMatter Servo brain surgery system.

Other new equipment included the largestmanufactured hyperbaric chamber and a new 3D mammography machine. LGMC's orthopedic team led Louisiana in MAKOplasty® joint procedures, while gaining certification from The Joint Commission in hip and knee replacement.

COMMUNITY IMPACT Patient response reflected the quality offered at LGMC. Newborn deliveries increased 13.4 percent. In fact, deliveries have increased 56 percent since 2012 (1,843). Surgeries rose 12 percent. Inpatient admissions increased 8.1 percent. This coincided with tremendous patient satisfaction scores. Free health screenings and seminars were well attended.

QUALITY A major focus of Quality/Infection Prevention at LGMC was aimed at reducing Central Line Bloodstream Infection (CLABSI) and Catheter-Associated Urinary Tract Infections (CAUTI), particularly in the adult Intensive Care Unit (ICU). That focus paid off, as the ICU saw dramatic drops in both CAUTI and CLABSI rates. FY'15 was the first year CAUTI was surveyed hospital-wide, and the 4th-floor orthopedic unit recorded zero CAUTI and CLABSI cases.

EMERGENCY DEPARTMENT

All five patients were treated and released within three days of the event. The staff represented LGMC well on the national stage.

UNIVERSITY HOSPITAL & CLINICS

University Hospital & Clinics (UHC) bustled with activity in fiscal year 2015. Landmark construction and renovation projects were underway. Recognitions and certifications reflected UHC's commitment to quality. Additionally, public services demonstrated a dedication to community outreach.

INVESTMENT Excitement built throughout the year as the hospital's ER expansion and renovation project kicked off in June. The \$4 million project, funded jointly by the State of Louisiana and Lafayette General Health, will more than double ER space.

Exterior painting of the building began to improve its visibility, appearance and energy efficiency.

Another positive transformation occurred on the 5th floor. In September, UHC opened its new Infusion Clinic on 5 East. This remodeled area separated infusion services from the Oncology Unit, where they were administered previously.

QUALITY While facilities were upgraded, UHC earned several achievements. UHC garnered Quality Respiratory

Care Recognition by the American Association for Respiratory Care for its qualified respiratory therapists.

UHC was one of only two Lafayette hospitals with this recognition (LGMC the other). UHC also achieved Level 2 WellSpot status from the Louisiana Department of Health and Hospitals. Offering healthy dining options and becoming a smoke-free campus aided this designation.

by offering free mammograms, breast screenings and followup care to eligible patients by working with Susan G. Komen, Inc., and the Louisiana Breast & Cervical Health Program. Louisiana exceeds the national average in breast cancer deaths, largely due to late or incurable-stage diagnoses, and UHC is now helping combat that.

One of the most touching honors of the year was Dr.

Richard Howes being named a "Master Pediatrician" by the

Louisiana Chapter of the American Academy of Pediatrics.

Dr. Howes has cared for children for some 40 years, and been
a fixture at UHC for most of that time.

ACADIA GENERAL HOSPITAL

Acadia General Hospital (AGH) celebrated its one-year anniversary with Lafayette General Health in fiscal year 2015. It was a watershed transition as AGH helped change the medical landscape in Acadia Parish.

CLOSER TO HOME The most dramatic influence was the influx of new physicians welcomed to Crowley. General Surgeon Max Trahan, M.D., opened his practice, followed by Internal Medicine physician Dale LeLeux, Jr., M.D. Women gained more local services with the arrival of OB/ GYN physician Jimmy Skrasek, M.D., and the certification of AGH Chief Medical Officer John Gonzalez, M.D., in Female Pelvic Medicine and Reconstructive Surgery. Oncologist/Hematologist Rebecca Davis, M.D., expanded the hours a physician was available at Cancer Center of Acadiana at AGH.

QUALITY Care at AGH also saw major improvements and innovations. In October, AGH announced a partnership with Schumacher Group to staff its ER. A new imaging center featuring an upgraded MRI system was opened at a new

location next to the AGH campus. Having the campus go smoke-free with improved dining options helped AGH earn Level 2 WellSpot status from the Louisiana Department of Health and Hospitals' "Well-Ahead Louisiana" initiative. Patients responded to these improvements, as patient satisfaction scores improved from the 50th percentile in 2014 to the 87th percentile in 2015.

COMMUNITY OUTREACH AGH expanded its community outreach efforts by hosting the "Lunch & Learn" series to educate the public about healthy habits and risks, as well as services offered in Crowley. The luncheons covered topics such as Heart Disease, Sports Medicine, Breast Cancer and Neuroscience. Other outreach activities included Family Fun Day, free screenings at the hospital's one-year anniversary celebration and the inaugural gala fundraising event to raise money for the new ER project.

LAFAYETTE GENERAL SURGICAL HOSPITAL

OIL CENTER SURGICAL PLAZA

It was an explosive year of growth for Lafayette General Surgical Hospital (LGSH) and for the launch of Oil Center Surgical Plaza (OCSP). Both entities, separately owned in part by Lafayette General Medical Center and local physicians, experienced new services, physicians and satisfied patients.

WORKING TOGETHER Located in the Medical Office Building at 1000 W. Pinhook Rd., LGSH (1st Floor) and OCSP (2nd Floor) shared a joint celebration November 7, 2014, kicking off a new era of cooperation. At the ceremony, OCSP officially opened and LGSH celebrated its 10-year anniversary. Their proximity allowed LGSH to continue to grow as a short-stay hospital with room for more complex procedures. OCSP, equipped with 7 pre-op beds, 4 operating rooms and 12 post-op/recovery beds, took on outpatient procedures ranging from ophthalmology, ENT, plastic surgery or pain management. The two independent facilities each enjoyed tremendous success, while allowing Lafayette General Medical Center to enhance its niche as

a highly specialized and advanced center for more critical procedures.

MORE SERVICES LGSH and OCSP saw their roles expand and evolve as the year progressed. New physicians and equipment at LGSH allowed for the first select spine and colorectal surgeries, expanded general, plastic and ENT surgeries, and the hospital's first gynecological services. After earning accreditation from the Accreditation Association for Ambulatory Healthcare, OCSP was able to expand its plastic and ENT services and begin pursuing podiatric services.

EXCELLENCE IN QUALITY LGSH was named a winner of two prestigious awards from Press Ganey Associates, Inc. LGSH received the Guardian of Excellence Award for consistently achieving patient satisfaction in the 95th percentile, and the Beacon of Excellence for doing so for three consecutive years. OCSP ended the fiscal year scoring 99% patient satisfaction.

ST. MARTIN HOSPITAL

St. Martin Hospital (SMH) continued to prosper and enhance its standards of quality during fiscal year 2015. The new outpatient and ER areas of the hospital saw patient satisfaction scores improve and patient volumes pushed hospital capacity regularly throughout the year.

QUALITY The environment of care at SMH impacted both patients and employees. The National Rural Health Association (NRHA) named SMH a Top 20 Critical Access Hospital in Patient Perspective. This placed SMH among the top of over 20,000 rural healthcare providers represented by the NRHA nationwide. The hospital was also selected by Modern Healthcare magazine as one of the 2015 Best Places to Work in Healthcare for the second-consecutive year, placing it among only 100 winners across the country.

CARING FOR THE COMMUNITY SMH was able to further meet community needs with Lafayette General Foundation securing a Susan G. Komen grant to provide free breast screenings. The \$74,988 grant helped treat uninsured and underinsured women and deliver education and navigation services. Additionally, the U.S. Department of Agriculture awarded a \$264,000 grant to SMH and four other rural South Louisiana hospitals towards developing telemedicine programs. SMH continues to explore opportunities for telemedicine across St. Martin Parish.

NEW AND IMPROVED The fiscal year culminated with two major announcements. First, Karen Wyble was introduced as new Chief Executive Officer. Wyble replaced former CEO Katie Hebert, who became Chief Operating Officer at University Hospital & Clinics. The second big development was the unveiling of plans for a 5,500 square-foot addition to the hospital. This expansion would increase staffed beds from 15 to 18, and eventually more, with a new specialty center for Outpatient Rehabilitation services and house SMH's accounting and patient financial services.

IMAGING DEPARTMENT

ABROM KAPLAN MEMORIAL HOSPITAL

It was a monumental year for Abrom Kaplan Memorial Hospital (AKMH) in many ways. The hospital celebrated its 55th anniversary after opening in the summer of 1960. The hospital also transitioned to full management under Lafayette General Health (LGH). These accomplishments coincided with a major renovation of the hospital.

A NEW ERA Although in a partial management arrangement since 2002, a full-management agreement between AKMH and LGH began June 1, 2015. This gave LGH full operational control of AKMH, while ownership of the property remained with Vermilion Parish Hospital Service District 1. Residents of the district still pay taxes to support the hospital, and LGH dedicates that revenue to benefit AKMH. In accordance with the hospital's original charter, it retained its name to honor town founder Abrom Kaplan.

A celebration ceremony was delayed, however, due to renovations underway that wouldn't be completed until late fall. Renovations included a newly painted interior and exterior, stormproof windows, air conditioning units

and furniture in patient rooms, a marquee sign, updated landscaping and a repainted parking lot for improved traffic flow.

QUALITY AND STABILITY The National Rural Health Association named AKMH a Top 20 Critical Access Hospital in Financial Stability for the second year in a row. Determining factors included competitive strength, competitive intensity, market size and growth, population risk, cost, charge, quality, outcomes, patient perspectives and financial stability.

AKMH was also recognized for reducing its "Harm Across the Board" rates. This was part of a three-year project by the CMS and AHA/HRET. From December 2011 through December 2014, nearly 1,500 hospitals in 31 states, including AKMH, engaged in this project. AKMH excelled by making elimination of harm its top priority and providing safety across the board.

With an intense focus on providing superior quality while containing and reducing the rising costs of healthcare, LGMD has positioned itself to be the physician group of choice for the communities we serve. LGMD operates and manages over 30 physician clinics in convenient locations throughout Acadiana. This high performing physician network includes specialists in Internal Medicine, Family

GRADUATE MEDICAL EDUCATION

Lafayette General Health (LGH) is affiliated with the LSU School of Medicine's Graduate Medical Education (GME) residency program at Lafayette General Medical Center (LGMC) and University Hospital & Clinics (UHC). LGH supports Acadiana's only two Major Teaching Hospitals.

Residents are medical school graduates who elect for additional years of training to meet advanced standards to practice medicine. These structured educational experiences follow specific requirements of an intern, resident or fellow's specialty and are carefully regulated by the program's site directors and GME faculty.

On any given day, there are close to 65 residents at UHC, with an additional 21 who rotate through LGMC between four to 12 weeks. The residents span a wide range of service lines, including Family Medicine, Internal Medicine, Otolaryngology (Ear, Nose & Throat), Ophthalmology, General Surgery, Obstetrics, Anesthesiology and Orthopedics. Fellowships (specific medical training available to those who have completed a residency program) are available in Cardiology, Geriatrics, Retina and Urogynecology.

Many physicians have stayed in Acadiana following the completion of their residency or fellowship. This keeps our community flush with new physicians and proves the tremendous value of graduate medical education in Lafayette.



LAFAYETTE GENERAL FOUNDATION

The story of La Place de Vie, a new courtyard at Lafayette General Medical Center, symbolizes Lafayette General Foundation's year. A cornerstone was set, a new flag was raised and it is now a revered outlet of remembrance. The Foundation enjoyed successful fundraising, new sponsorships, and new programs, creating a vibrant philanthropic venue.

EVENTS ORGANIZED The Foundation organized two gala events. The first was the annual gala benefiting the Foundation's general fund. The second was the inaugural gala in Crowley to assist Acadia General Hospital's new ER project. Other events included the first-ever Foundation Golf Tournament held at Oakbourne Country Club in June, and the "In Skilled Hands" art auction at the Paul and Lulu Hilliard University Art Museum in March. These events helped build relationships, raise awareness and grow potential resources.

FOR A GOOD CAUSE Being a good community partner is vital to the Foundation's role, which is why sponsorships are important. The Foundation helped sponsor several events, including the Chitimacha Louisiana Open Volunteer Services; the U.S. Youth Soccer Region III Presidents Cup;

and Maddie's Footprints' 5K Run and Walk. Funding was made possible in part through the launch of a Lafayette General Health employee-giving campaign called "We Give." During its first month, employees contributed \$30,000.

INVESTING IN OUR COMMUNITY The Foundation aims to support innovations that transform care and improve outcomes. There is no better example of this than telemedicine clinics the Foundation helps establish. During the year, telemedicine arrived at schools in Carencro and St. Martin Parish. The Foundation also helped secure key grants and donations to aid programs across the system. A Susan G. Komen grant provided free breast screenings at St. Martin Hospital; a Project LAUNCH grant boosted the pediatric clinic at University Hospital & Clinics; and a Kiwanis Club of Lafayette donation helped purchase a Total Body Cooling System for premature babies at LGMC. The Foundation also brought "Bright Ideas" to life: free scales for heart-failure patients; multipurpose carts for ER staff; and new wheelchairs for cancer patients.






