I. Objektif

- G. Chaj Brit – Total chaj nan pousantaj etablisman konplè etablisman an pou dispozisyon pou sèvis swen pasyan anvan dediksyon nan revni yo aplike.
- H. Medikalman Nesèsè – Sèvis ki rezonab oswa nesesè pou dyagnostik la oswa tretman pou yon maladi oswa aksidan. Doktè egzaminen an pral detèmine nesesite medikal.

2. Pasyan yo dwe kolabore ak pwosed Ochsner pou jwenn Asistans Finansye oswa lòt fòm peman, epi pou kontribye nan depans swen yo ki baze sou kapasite endividyle yo pou peye.
 - a. Si ou pa konfòme ou avèk pwosesis tès depistaj Asistans Finansye Ochsner a, ki gen ladan men pa limite a, detèminasyon pwoteksyon Medicaid, yo pral eskli pasyan yo nan kalifikasyon Asistans Finansye.
 3. Asistans finansye aplike pou responsabilite pasyan sèlman, ki gen ladan, men pa limite a sa sèlman, franchiz, ko-peiman, ak ko-asirans epi li disponib pou rezidan nan Lwizyana ak Mississippi. Kalifikasyon pou Asistans Finansye detèmine ki baze sou Revni Fanmi pasyan an, byen, ak gwochè fanmi an.
 4. Ochsner dwe bay yon rabè 100% Asistans Finansye pou sèvis ki kalifye pou pasyan ki gen revni Fanmi yo nan 200% nan Gid FPL yo oswa mwens.
 5. Pasyan ki gen revni Fanmi depase 200% nan FPL la ka elijib pou resevwa pousantaj rabè ki baze sou sikonstans espesifik yo, tankou maladi katastwofik oswa endijans medikal, selon diskresyon Ochsner. Pou eksepsyon, dokiman yo ka oblige kalifye pou Asistans Finansye. Eksepsyon yo enkli, men yo pa limite a sa sèlman:
 - a. Medikaman chè ak bòdwo lopital / doktè.
 - b. Tèminal maladi; oswa
 - c. Plizyè entène lopital.
 6. Si ou pa konfòme ou avèk pwoteksyon Medicaid Ochsner a ak pwosesis tès depistaj Asistans Finansye a ap eskli pasyan yo nan kalifikasyon pou Asistans Finansye.
