Kritè Kalkil AGB

Pou yo kalkile AGB, Ochsner Health gen ladan sèlman kont ki satisfè kondisyon sa yo:

- Kont lan gen yon peman asirans ki afiche ant 5 septanm 2024 rive 4 septanm 2025.
 - Enfòmasyon sou Entèval Dat yo: Done yo chwazi yo kouvri yon peryòd 12 mwa youn apre lòt, epi dat fen an pa dwe rive plis pase 120 jou anvan dat antre an vigè (1ye janvyè 2026) nouvo tarif yo.
- Balans asirans lan = \$0.
